## Church bells endowment is sound investment



Carl and Mary Kay Wolford chose to establish a new endowment to fund the maintenance of the church bells and clock.




Earlier this year, when the couple learned about the repairs needed for the bells and clocks in the Archabbey Church, one part of the project drew their interest. Saint Meinrad had decided that, as part of the project, it would seek an endowment for future maintenance of the bells.

Mary Kay vividly remembers President-Rector Fr. Denis Robinson, OSB, talking about the bells and their meaning to the monastic community. "They are our heartbeat," he said. "They symbolize our life source as they announce the times for prayer and special occasions." As frequent visitors to the Hill, the Wolfords appreciated how the bells underscore the rhythm of the place.

With that in mind, they decided to fund the endowment to ensure that future maintenance and

repairs would keep the bells and clocks in good condition. "Besides the beautiful sound that you hear from the bells, it's the tradition of the younger monks ringing them. It's part of their formation to continue that tradition," says Mary Kay.

The interest earned on the endowment will be used to pay for the care and upkeep of the church bells and tower clocks. The endowment's principal remains intact, allowing the interest to accumulate and be used for this purpose in perpetuity.

Guiding their philanthropy – to Saint Meinrad and others – is the Wolfords' focus on stewardship. "Saint Meinrad is an example of a good steward," says Carl. "My definition of stewardship is accepting your gifts – gifts that are entrusted to you by God – graciously, managing them while you're holding them, and sharing them with others in justice and love."

Mary Kay agrees and encourages others to be generous with what they've been given. "I tell people all the time, 'You can't give away more than you get back.'" She explains, "You have to start and just have faith. You don't give to get something back, but if you give in good faith, you receive much more than you give."

Saint Meinrad is not the only place to recognize the Wolfords' charitable work. Last October, in Washington, D.C., they were honored for their commitment to Catholic education with the Saint Elizabeth Ann Seton Award given by the National Catholic Educational Association. Indianapolis Archbishop Joseph W. Tobin, CSsR, (now Cardinal of the Archdiocese of Newark) nominated Carl and Mary Kay for the award.

## The Gift That Keeps On Giving

1. Personal Satisfaction.

Making a real difference by doing something important and lasting is highly satisfying. Many donors tell us that having their family name on a fund fulfills one of their highest personal ambitions while honoring loved ones.


- 2. Strengthening Saint Meinrad. We will always need to raise funds to sustain our facilities, programs and personnel. However, the annual endowment payout eases some of the financial pressure. Having a strong endowment allows Saint Meinrad to have a financially stable future.
- 3. **The Name Lives On.** A donor's name can be attached to an endowment

fund, and because the funds are permanent, this legacy will carry that name in perpetuity and perhaps influence future generations in the family.

4. **Continue Annual Gifts**. Some friends recognize that their regular gifts each year will be missed once they can no longer be made. To continue the pattern, they create an estate gift that is 25 times the amount they currently give each year to Saint Meinrad. For example, Marie and Thomas, who give \$1,000 annually, can endow these contributions by making a one-time gift of \$25,000.

5. **Permanence.** Many friends see a connection between their retirement funds and our endowment funds. Both are protected and managed separately, so the principal retains its purpose. Our endowments are managed like a retirement account, providing needed income in a predictable way.
